**A RESOLUTION OF THE ESPARTO COMMUNITY SERVICES DISTRICT
REQUESTING THE YOLO LOCAL AGENCY FORMATION COMMISSION PROCESS
AN ANNEXATION APPLICATION FOR THE DISTRICT OWNED WASTEWATER
TREATMENT FACILITY PARCELS PER THE CORTESE-KNOX-HERTZBERG LOCAL
GOVERNMENT REORGANIZATION ACT OF 2000 AND AUTHORIZING AND
DIRECTING THE GENERAL MANAGER TO FILE AN ANNEXATION APPLICATION
WITH THE YOLO LOCAL AGENCY FORMATION COMMISSION**

WHEREAS, the Esparto Community Services District (“District”) is a duly organized and existing community services district operating under the laws of the State of California (Government Code §61000 et seq.); and

WHEREAS, the District owns and operates wastewater treatment facilities located on the following parcels within Yolo County, identified as Assessor’s Parcel Numbers **049-130-007, 049-130-013, 049-120-038, and 049-130-050**; and

WHEREAS, these parcels currently lie outside the formal boundary of the Esparto Community Services District but are used solely for public purposes associated with the District’s wastewater treatment operations; and

WHEREAS, annexation of these parcels into the District’s jurisdictional boundaries will align the legal boundaries with the District’s existing operational footprint, provide administrative efficiency, and result in a reduction of property tax obligations for the District as the public agency owner; and

WHEREAS, pursuant to the **Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000** (Government Code §56000 et seq.), annexation proceedings must be initiated by resolution of application adopted by the legislative body of the affected district; and

WHEREAS, the District desires to submit an application to the **Yolo Local Agency Formation Commission (LAFCo)** requesting annexation of the above-described parcels into the Esparto Community Services District boundary.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Esparto Community Services District as follows:

The Board hereby initiates proceedings with the Yolo Local Agency Formation Commission for the annexation of Assessor's Parcel Numbers **049-130-007, 049-130-013, 049-120-038, and 049-130-050** to the Esparto Community Services District.

The General Manager is hereby **authorized and directed** to prepare and submit the necessary application materials, maps, and documentation to Yolo LAFCo and to take all actions necessary to effectuate the intent of this resolution.

This Resolution of Application is adopted pursuant to Government Code §56654 and shall be transmitted to Yolo LAFCo in accordance with applicable state and local procedures.
